Official Rules

Caller ten (10) to the Station, as determined by the Station in its sole discretion, will win be a potential winner of a Prize after providing the Station with the listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
