

## **WQUT Present's "WQUT Limited Edition" 30 Years of Classic Rock T-Shirt & Bristol Race Tickets" On Air Giveaway!**

### **Official Rules**

A complete copy of these rules can be obtained at the offices of radio station WQUT ("Station"), owned and operated by Cumulus Radio LLC located at 162 Free Hill Road, Gray, TN 37615, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to WQUT, 162 Freehill RD Gray TN 37615.

The Station will conduct the **WQUT "WQUT Limited Edition" 30 Years of Classic Rock TShirt & Bristol Race Tickets" On Air Giveaway!** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void, where prohibited. All federal, state, and local regulations apply.**

**Eligibility.** This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the six (6) months. **Void where prohibited by law.** Employees of Cumulus Radio LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, and other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and stepsiblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes the entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- Contest Period.** The Contest entry period will begin at 10:01 a.m. ET on **July 28<sup>th</sup> , 2025** and will **run through from 10:01 a.m. ET through 4:59 p.m. ET on August 8<sup>th</sup> , 2025** (the "Contest Period"). The Station's computer is the official timekeeping device for this Contest.

- **How to Enter/Win.**

**On-Air:** During the Contest Period, listen to the Station from 10:01 a.m. ET to 4:59pm ET during the Contest Period for the “cue to call.” Call in at 423.477.1015. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will be a potential winner of a Prize after providing the Station with the listener’s name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station’s analog over-the air signal and the Station’s online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station’s analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be required to sign and return to Station, within three (3) days of the date of notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who signs the affidavit of eligibility and the liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign the affidavit of eligibility and the liability/publicity release within the required time (if applicable), or the prize or prize notification is returned as undeliverable, the potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

The Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
